What does the fund invest in?

The Fund seeks long-term capital growth and some income by investing primarily in other mutual funds with a mix of investment styles that invest in equities and fixed income securities, although it may also invest in securities directly. It generally holds 80% of its assets in equities and 20% in fixed income securities.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Mackenzie has rated the volatility of this fund as low to medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell QFW Series securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

We provide eligible investors with combined management and administration fee decreases on their eligible Mackenzie fund investments, as disclosed under the sub-heading "Fund expenses". If you or your eligible accounts, as applicable, no longer meet the requirements to be eligible for QFW Series, we may automatically switch your securities into QF Series, which has higher combined management and administration fees than QFW Series. See "Fees and Expenses" in the Fund's simplified prospectus and speak to your representative for additional details.

1. Sales charges

You can only buy this series of the fund under the no load purchase option. No sales charges are payable by you under this purchase option.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

The fund's expenses are made up of the management fee, fixed administration fee, other fund costs and trading costs. The series' annual management fee is 0.80% of the series' value. The series' annual fixed administration fee is 0.15% of the series' value.

Because this series is new, other fund costs and trading costs are not yet available.

The fee decrease from QF Series to QFW Series is 0.29%.

3. Other fees You may have to pay other fees whe	en you buy, hold, sell or switch securities of the fund.
Fee	What you pay
Switch fees	If you switch between series of the Fund or to another fund within the Quadrus Group of Funds, then you may pay your representative's firm a switch fee of 0-2%, subject to the following exception – no switch fees are payable when switching between QF Series, QFS Series and QFWS Series securities.
Inappropriate short-term trading fee	A fee of 2% of the amount switched or redeemed will be charged by the Fund for inappropriate short-term trading.
Excessive short-term trading fee	A fee of 1% of the amount switched or redeemed will be charged by the Fund if you invest in the fund for less than 30 days and your trading is part of a pattern of short-term trading that Mackenzie believes is detrimental to fund investors.
Advisor Service Fee	You may pay a service fee, which is negotiable with your investment representative and your representative's firm, for services provided in connection with your QFW Series investments. This service fee may not exceed 1.25% and will be collected by Mackenzie through redemptions of these securities in your account and then the proceeds will be remitted to your representative's firm.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
