

# Growth and Income Class (GWLIM) – L Series

## What does the fund invest in?

The Fund seeks long-term capital growth and income by investing primarily in equities issued by companies around the world and Canadian fixed income and money market securities, directly, through other investment funds or through derivatives that provide exposure to such securities or investment funds. The Fund's asset mix will generally range between 40% to 70% equities and 30% to 60% fixed income securities. The Fund may hold up to 49% of its assets in foreign investments.

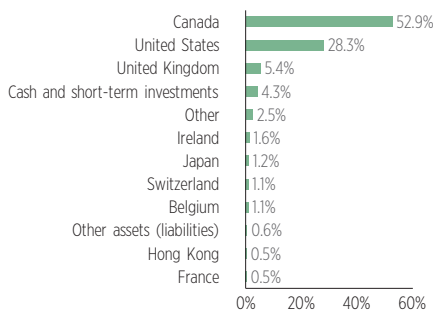
The charts below give you a snapshot of the fund's investments on April 30, 2018. The fund's investments will change.

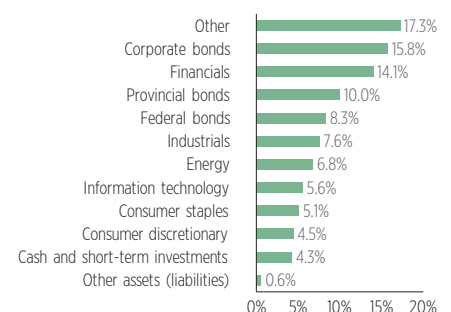

## How risky is it?

The value of the fund can go down as well as up. You could lose money.

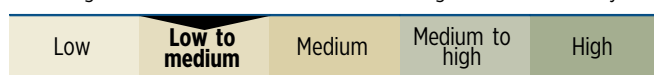
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

Mackenzie has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

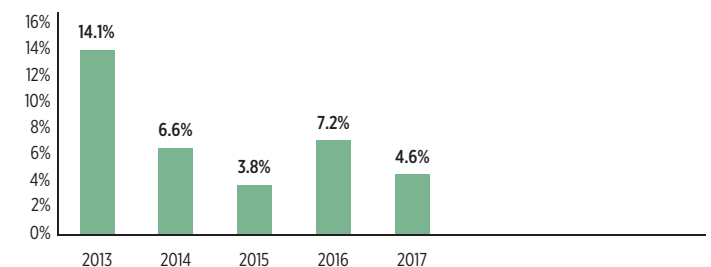
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

## How has the fund performed?

This section tells you how L Series securities of the fund have performed over the past 5 years. Returns are after expenses have been deducted. These expenses reduce returns.

### Year-by-year returns

This chart shows how L Series securities of the fund performed in each of the past 5 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



**Best and worst 3-month returns**

This table shows the best and worst returns for L Series securities of the fund in a 3-month period over the past 5 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

**Average return**

A person who invested \$1,000 in L Series of the fund since its inception would have had \$1,432 as of April 30, 2018. This is equal to an annual compounded return of approximately 6.8%.

**Who is this fund for?**

**Investors who:**

- are looking for a Canadian balanced fund to hold as part of their portfolio
- want a long-term investment
- can handle the volatility of stock and bond markets

**This Fund is not recommended for registered plans. Registered plans should consider Growth and Income Fund (GWLIM) instead.**

**A word about tax**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell L Series securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

We provide eligible investors with combined management and administration fee decreases on their eligible Mackenzie fund investments, as disclosed under the sub-heading “Fund expenses”. If you or your eligible accounts, as applicable, no longer meet the requirements to be eligible for L Series, we may automatically switch your securities into Quadrus Series, which has higher combined management and administration fees than L Series. See “Fees and Expenses” in the Fund’s simplified prospectus and speak to your representative for additional details.

**1. Sales charges**

You have to choose a sales charge option when you buy this series of the fund. Ask about the pros and cons of each option.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of March 31, 2018, the fund's expenses were 2.13% of its value. This equals \$21.30 for every \$1,000 invested.

The fee decrease from Quadrus Series to L Series is 0.36%.

**More about the trailing commission**

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

Mackenzie pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

- **Sales charge purchase option** – 1.00% of the value of your investment each year (\$10.00 per year for every \$1,000 invested)
- **Redemption charge purchase option** – 0.50% of the value of your investment for years 1-7, and 0.50% for each year after that (\$5.00 per year for every \$1,000 invested)
- **Low-load purchase option** – 0.50% of the value of your investment for years 1-3, and 1.00% for each year after that (\$5.00 to \$10.00 per year for every \$1,000 invested)

**3. Other fees**

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
<b>Switch fees</b>	If you switch between series of the Fund or to another fund within the Quadrus Group of Funds, then you may pay your representative's firm a switch fee of 0-2%.
<b>Inappropriate short-term trading fee</b>	A fee of 2% of the amount switched or redeemed will be charged by the Fund for inappropriate short-term trading.
<b>Excessive short-term trading fee</b>	A fee of 1% of the amount switched or redeemed will be charged by the Fund if you invest in the fund for less than 30 days and your trading is part of a pattern of short-term trading that Mackenzie believes is detrimental to fund investors.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
