What does the fund invest in?
The Fund seeks long-term capital growth and dividend income by investing primarily in U.S. equities that produce dividend income and offer above-average yields, and/or have potential for growing their yields, either directly or through other investment funds. The Fund may invest up to $30 \%$ of its assets in non U.S. equities.

## How risky is it?

The value of the fund can go down as well as up. You could lose money.
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".
In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

Mackenzie has rated the volatility of this fund as medium.
This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Average return
A person who invested $\$ 1,000$ in D5 Series of the fund since its inception would have had $\$ 1,841$ as of April 30,2018 . This is equal to an annual compounded return of approximately $13.6 \%$.

## Who is this fund for? <br> Investors who:

- are looking for a U.S. income-oriented equity fund to hold as part of their portfolio
- are looking for capital growth and dividend income
- want a medium- to long-term investment
- can handle the volatility of stock markets
- want to receive a monthly cash flow

This Fund is not recommended for registered plans. Registered plans should consider U.S. Dividend Fund (GWLIM) instead.

## A word about tax <br> In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account. <br> Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell D5 Series securities of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

We provide eligible investors with combined management and administration fee decreases on their eligible Mackenzie fund investments, as disclosed under the sub-heading "Fund expenses". We will automatically switch your D5 Series securities into L5 Series securities of the Fund (bearing lower combined management and administration fees) upon your investment amount in eligible Mackenzie funds meeting the L5 Series eligibility requirements of $\$ 100,000$ minimum series investment and $\$ 500,000$ minimum total holdings. If you or your eligible accounts, as applicable, no longer meet the requirements to be eligible for L5 Series, we may automatically switch your securities into D5 Series, which has higher combined management and administration fees than L5 Series. See "Fees and Expenses" in the Fund's simplified prospectus and speak to your representative for additional details.

1. Sales charges

You have to choose a sales charge option when you buy this series of the fund. Ask about the pros and cons of each option.

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of March 31, 2018, the fund's expenses were $2.62 \%$ of its value. This equals $\$ 26.20$ for every $\$ 1,000$ invested.

## More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.
Mackenzie pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

- Sales charge purchase option $-1.00 \%$ of the value of your investment each year ( $\$ 10.00$ per year for every $\$ 1,000$ invested)
- Redemption charge purchase option $-0.50 \%$ of the value of your investment for years 1-7, and $0.50 \%$ for each year after that ( $\$ 5.00$ per year for every $\$ 1,000$ invested)
- Low-load purchase option - $0.50 \%$ of the value of your investment for years $1-3$, and $1.00 \%$ for each year after that ( $\$ 5.00$ to $\$ 10.00$ per year for every $\$ 1,000$ invested)

The fee decrease from D5 Series to L5 Series is $0.43 \%$.
3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Excessive short-term trading fee A fee of $1 \%$ of the amount switched or redeemed will be charged by the Fund if you invest in the fund for less than 30 days and your trading is part of a pattern of short-term trading that Mackenzie believes is detrimental to fund investors.

What if I change my mind?
Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
